SELECTION

The WRLA Board of Directors will carefully evaluate all nominations and select the recipient at the next WRLA Board meeting.

PRESENTATION OF AWARD

The recipient will be notified as the selected winner prior to the awards event. The award recipient will be announced to WRLA members prior to the awards event.
